## 2. Reasons for revision

Primary factor for the revision is as follows.

Yumeshin Holdings has revised its forecasts as the acquisition of capital stake in Toa Construction Engineering Co., Ltd. and the signing of Katsumura Construction sponsorship contract which were both announced in December 26, 2005, will be reflected in company's business performance in the second half of the current fiscal year. The revisions will have no effect on interim consolidated business results and nonconsolidated financial statements.
